Acuerdo 09/2025 por el que se da a conocer el ajuste por actualización de las variables de la fórmula de distribución de las participaciones federales ministradas provisionales y definitivas, a cada uno de los municipios del estado de Yucatán, en el ejercicio fiscal 2025

Joaquín Jesús Díaz Mena, Gobernador del Estado de Yucatán, con fundamento en los artículos 55, fracciones I y II, y 60 de la Constitución Política del Estado de Yucatán; 2, 2-A, 3-A, 4, 4-A, 6 y 7 de la Ley de Coordinación Fiscal; 14, fracciones VIII y IX, del Código de la Administración Pública de Yucatán; y 1, 5, numerales 1, 3, 5, 6, 7 y 7 Bis de la Ley de Coordinación Fiscal del Estado de Yucatán, y

Considerando:

Que el Presupuesto de Egresos de la Federación para el Ejercicio Fiscal de 2025 establece, dentro de sus ramos generales, recursos del Ramo 28 "Participaciones a Entidades Federativas y Municipios", cuya distribución se encuentra prevista en el capítulo I de la Ley de Coordinación Fiscal, en el artículo 14 de la Ley Federal del Impuesto sobre Automóviles Nuevos, así como en los convenios de colaboración administrativa en materia fiscal federal.

Que, de conformidad con lo previsto en el artículo 6, penúltimo párrafo, de la Ley de Coordinación Fiscal y en el Acuerdo 02/2014 por el que se expiden los Lineamientos para la publicación de la información a que se refiere el artículo 6o de la Ley de Coordinación Fiscal, publicado en el Diario Oficial de la Federación el 14 de febrero de 2014, es una obligación a cargo de las entidades federativas coordinadas publicar, en el periódico oficial de la entidad, el importe de las participaciones federales entregadas a sus municipios y, en su caso, el ajuste realizado.

Que la Ley de Coordinación Fiscal, en su artículo 7o, último párrafo, determina que, durante los primeros cinco meses de cada ejercicio, las participaciones en el Fondo General de Participaciones a que se refiere la fórmula prevista en el artículo 2o. de la referida ley, así como las que se establecen en los artículos 2-A, fracciones I y III, y 3-A de dicha ley, se calcularán provisionalmente con los coeficientes del ejercicio inmediato anterior, en tanto se cuente con la información necesaria para calcular los nuevos coeficientes.

Que los recursos que participe la federación por incentivos a la venta final de gasolinas y diésel, se distribuirán, en la proporción que corresponda a los municipios con base en lo dispuesto por el artículo 6 Bis, fracción III, de la Ley de Coordinación Fiscal del Estado de Yucatán.

Que el 14 de febrero de 2025 se publicó, en el suplemento del Diario Oficial del Gobierno del Estado de Yucatán, el Acuerdo 04/2025 por el que se dan a conocer el calendario de entrega, los porcentajes y los montos estimados de las participaciones federales y estatales que recibirá cada municipio del estado de Yucatán en el ejercicio fiscal 2025.

Que de conformidad con lo establecido en los artículos 10, 11, 12, párrafo segundo, 13 y Anexo I del Acuerdo 04/2025 mencionado en el párrafo que antecede, la distribución entre los municipios del estado de Yucatán de los montos estimados se

realizó con base en los coeficientes determinados de conformidad con la Ley de Coordinación Fiscal y la Ley de Coordinación Fiscal del Estado de Yucatán.

Que los coeficientes preliminares referidos en el considerando previo deben ser ajustados a partir de que se cuente con la información correspondiente y se aplicarán, retroactivamente, a partir de enero del ejercicio fiscal 2025, en términos del artículo 7o, último párrafo, de la Ley de Coordinación Fiscal, y del artículo 7 Bis de la Ley de Coordinación Fiscal del Estado de Yucatán, por lo que he tenido a bien expedir el presente:

Artículo 1. Actualización de coeficientes

Se dan a conocer los coeficientes definitivos que corresponden a cada municipio del Estado de Yucatán, conforme a los factores de distribución obtenidos mediante la actualización de las variables de la fórmula de distribución de las Participaciones Federales, correspondientes al Fondo General de Participaciones, Fondo de Fomento Municipal, Impuesto Especial sobre Producción y Servicios, Fondo de Fiscalización y Recaudación, Impuesto Especial Sobre la Venta Final de Gasolina y Diésel, Fondo de Compensación del Impuesto sobre Automóviles Nuevos, Impuesto Sobre Automóviles Nuevos e Impuestos estatales aplicados, comprendidos en los anexos siguientes:

I. Anexo I. Desarrollo de factor de distribución de las participaciones federales y estatales, periodo julio 2025-junio 2026.

II. Anexo II. Desarrollo del factor de distribución del Impuesto Especial sobre la Venta Final de Gasolina y Diésel, periodo julio 2025-junio 2026.
